The attention of all the Regional Joint Director of School Education and District Educational Officers in the state are invited to the reference 7th read above, wherein Government ordered to effect the **Inter-District Transfer of Teachers as per 5(2)(c) of Presidential Order on Spouse Grounds – 141 requests as appended at Annexure-I, 5(2)(d) on Mutual basis-332 requests as appended at Annexure-II and 4 Ex-Servicemen requests** in relaxation of relevant rules, as appended at Annexure-III, subject to assign last rank next to the last regular candidate in the new unit of appointment. An undertaking should be obtained by the DEO concerned to that effect from the candidate and recorded in the Service Register.

Further, Government directed to effect the Inter-District Transfer of the teachers as ordered in the above Para, with immediate effect. **All the Head Masters and the School Assistants would stand relieved and deputed in the same post after joining at the new place of posting so that academic session is not disturbed.** They will again revert back after completing their deputation after the examinations are over in the School, before general transfers take place. **All the Secondary Grade Teachers, Language Pandits and Physical Education Teachers would also stand relieved, and will join at the new place of posting but they deputed only as per**

requirement.

Further, it is informed that, the individuals effected in this Inter-District Transfer are **not entitled to any TA/DA** as the transfer are ordered on a request basis.

Therefore, all the Regional Joint Director of School Education and District Educational Officers in the state are directed to take further necessary action accordingly as ordered by the Government and report compliance.

This should be treated as **"MOST URGENT"**.
