ORDER :

In the G.O. 3rd read above. Government have constituted a Committee to review the working of the A.P.G.L.I. Scheme and to make suitable recommendations thereto.

The Director of Insurance has stated that in the G.O. 1st and 2nd read above. Government have standardized certain forms which are in common use by the subscribers of A.P.G.L.I. Department. The Director of Insurance has proposed that the standard forms are to be simplified in view of the present circumstances and for disposal of the cases quickly as follows:

1. Form No. 1: Proposal for Insurance on own life.
2. Form No. 12: Form for application of Refund of Policy amount (Form for Maturity)
3. Form No. 13: Form for application of Refund of amount (form for Death cases)
4. Form No. 29: Application for Loan.
5. Form No. 33: Form for Fair policy.
6. Form No. 47: Form for premium cum loan schedule - Big size.
7. Form No. 48: Form for premium cum loan schedule - small size.
8. Form No. 1A: Form for further insurance on Own life.
9. Form No. 33A: Form for Endorsement slip.

The committee has gone into the simplification of forms, as proposed by the Director of Insurance and suggested to accept the proposal.

Government after careful consideration of the recommendations of the Committee and in super session of the orders issued in the G.O. first and 2nd read above hereby order that the simplified forms given in the annexure be treated as standardized forms and accord administrative sanction to the form No. 33-A i.e. form for Endorsement slip for use in A.P.G.L.I. Department in addition to the forms mentioned in Annexure-I of the G.O. first read above.

The Commissioner of Printing and Stationary is requested to arrange for printing and supply of these forms to the various Departments against their indents.
