**ORDER: A P U S**

In the reference 1st read above, Government have permitted the Director of School Education, Andhra Pradesh, Hyderabad to issue appointment orders to the selected candidates of DSC-2003 under Rule 10(a) of Andhra Pradesh State and Subordinate Service Rules, 1996.

2.In the reference 2nd read above, Government have issued orders permitting the Director of School Education, Hyderabad to appoint 303 candidates who have applied for DSC-2002 and who have undergone training prior to 17.08.1995 and 16.06.2000 as per the directions of the APAT in respect of Orissa and Karnataka States respectively. The detailed guidelines has also been given in same order.

3. While the things stand thus, the candidates who have not been covered by the said G.O. have separately filed the different O.As before APAT for orders in their favour. The Hon'ble APAT has issued interim directions in 15 OAs wherein 429 candidates have been covered to keep 429 posts of Hindi Pandit Grade-I and Grade-II reserved for the applicants, until further orders.

4.The Director of School Education, Hyderabad vide his Lr.Dt.23.01.2006 has stated that, the A.P.A.T. issued interim orders directing only to reserve 429 posts of Hindi Pandits Grade-I and Grade-II for the applicants until further orders. It is proposed to reserve the above posts. It is further proposed to issue appointment orders to DSC-2003 Hindi Pandits without issuing appointment orders to DSC-2002 candidates ordered in the reference 2nd read above.

5.In the circumstances stated above, the Government after careful consideration in the matter hereby permit the Director of School Education, Andhra Pradesh, Hyderabad to issue appointment orders to the Hindi Pandits Grade-I and Grade-II of DSC-2003, subject to condition that their appointments are without prejudice to the seniority of the DSC-2002 Hindi Pandits Grade-I and Graded-II candidates ordered to be appointed in the reference 2nd read above and in other cases if any pending before Andhra Pradesh Administrative Tribunal/Andhra Pradesh High Court etc.,

6. The Director of School Education. Andhra Pradesh, Hyderabad shall take action accordingly.
