Government after careful consideration of the proposal contained in the reference 9th read above, hereby permit the Commissioner & Director of School Education, Hyderabad to initiate the process of recruitment to fill up 16,449 posts of teachers.

2. The recruitment shall be in accordance with the rules framed by Government in G.O. fourth read above., i.e., Andhra Pradesh Direct recruitment of Teachers Scheme of Selection) Rules 2000 and subsequent amendments issued thereto.

3. All the conditions prescribed in the G.Os at first, fourth, fifth, sixth, seventh and eighth read above shall apply mutatis-mutandis to this process of general recruitment of teachers besides any orders issued by Government.

4. The Commissioner & Director of School Education, Hyderabad is requested to notify the number of vacancies Dist. wise separately.

5. A detailed schedule relating to the issue of notification and calling for applications and conduct of examination shall be notified by the Commissioner & Director of School Education, Hyderabad.

6. The Commissioner & Director of School Education, Hyderabad and Chairmen D.S.C.s shall scrupulously adhere to the terms of the schedule.
