In the G.O. read above, Government have issued orders that the Apprentice period of Teachers shall be count for the purpose of 8/16/24 years Automatic Advancement Scheme. The Amount to be drawn (arrears) by the teachers in this regard shall be remitted to GPF. Government further direct that the Director of School Education-Hyderabad / all District Educational Officers shall verify the above aspect in each individual case and take further action, any improper counting of service shall be viewed seriously and the financial implications/loss sustained to the Government on account of such irregularation is liable to be recovered from the Staff concerned apart from taking other action as per rue.
