**ORDER:**

In the Government Order 1st read above, orders were issued introducing Automatic Advancement Scheme w.e.f. 1-4-1981. In the G.O. 2nd read above orders issued extending the scheme to the Teachers. In the G.O. 3rd read above orders were issued revising Automatic Advancement Scheme in respect of teachers in the light of regrouping of pay scales of Teachers with effect from 1-12-82 vide G.O.Ms.No. 1000(S) Edn. dt 17-12-1982. In the G.O. 4th read above, orders were issued liberalizing the Automatic advancement Scheme with effect from 1-7-86 in the light of recommendations of P.R.C.1986.

In the G.O. 5th read above, orders were issued on the liberalized Automatic Advancement Scheme in respect of Teachers. In the G.O. 6th read above, orders were revised Automatic Advancement Scheme w.e.f. 1.8.1993 as per the recommendations of PRC 93. Subsequently, these orders were modified and shall come into force w.e.f 1.7.92 instead of from 1.8.1993 with monetary benefit from 1-4-1993 in G.O. Ms. No. 362, Finance dated 28-10-1994.

It has come to the notice of the Government that the Administrative Authorities have been applying the Automatic Advancement Scheme and fixation of pay was made which subsequently found to be erroneous due to the non eligibility of the Teachers as they did not fulfill the conditions stipulated in Automatic Advancement Scheme. In such cases re-fixation has to be done and the amounts drawn on erroneous pay fixation have to be recovered as the individuals are not eligible for the same.

The Government after careful examination of the matter hereby order that the amounts drawn by the individuals in contravention of the rules applicable to the Automatic Advancement Scheme shall be recoverable in not exceeding 12 easy installments.

Accordingly the following amendment to the G.O. second read above is issued.

The amendment hereby made shall be deemed to have come into force with effect on and from the 1st April, 1981 i.e. date from which orders in read above, were given effect to.

#### **AMENDMENT**

In the said G.O. after para 9 the following shall be added namely:

"10 Any amounts drawn in contravention of these rules shall be recoverable in not exceeding 12 easy installments."
