In the reference cited Government have introduced second level Automatic Advancement Promotion Post in respect to employees who have completed 22 years of service in a particular category. These orders have come into force from 1-7-1986.

2. A question has arisen as to how to fix the pay of employee who might have completed 22 years of service on or before 1-7-1986 but have opted to come into revised pay scales, 1986 from their date of normal increment which is subsequent to 1-7-86.

3. Government after careful consideration hereby clarify that the benefit of second level Automatic Advancement post be given in the 1978 pay scales from 1-7-1986 in respect of employees who have completed 22 years of service on or before 1-7-1986 but have opted to come into Revised Pay Scales on the date of normal increment which is subsequent to 1-7-1986, Their pay shall however be fixed in the Revised Pay Scales, 1986 from the date of their option direct in the pay scales applicable to the second level Automatic Advancement promotion post (An Illustration is worked out in the Annexure).
