ORDER:

A P U S

In the orders first read above, a scheme of Automatic Advancement was introduced for the benefit of those State Government employees who are drawing pay in the Revised Pay Scales of 1978 falling under Grades I to XVIII other than teaching staff of the Schools Junior and Degree colleges who have put in ten or fifteen years of service in a scale without getting promotion to a higher post. Keeping in view the various kinds of situations that arose in the course of implementation of this scheme, numerous clarifications and amendments to the scheme were issued from time to time.

2. The pay Revision Commissioner, 1986 among other things has recommended for the continuation of the Automatic Advancement Scheme. In addition to the above he has also recommended for extension of the scheme to the employees drawing pay upto Grade XVIII in the Revised Pay Scales 1986. He has further introduced another level of Advancement after completion of 22 years of service. In the orders second read above, orders were issued revising the Automatic Advancement Scheme as recommended by the Pay Revision Commissioner, 1986. Keeping in view the various situation that arose in the course of implementation of the scheme numerous clarifications and amendments were issued from time to time.

3. However it has come to the notice of the Government that the Administrative Authorities have been applying the Automatic Advancement Scheme and fixation of pay were made subsequently found to be erroneous due to their non-eligibility of the employees and they did not fulfill the conditions stipulated in the said Automatic advancement Scheme. In all such cases re fixation has to be done and the amounts drawn on such erroneous pay fixation have to be recovered as the individuals were not eligible for the same.

4. The Government after careful examination of the matter hereby order that the amounts drawn by the individual due to erroneous fixation or pay in contravention of the rules applicable to the Automatic Advancement Scheme shall be recoverable in not exceeding 12 easy installments.

5. Accordingly, the following amendment to the orders read above is issued.

6. The amendment hereby made shall be deemed to have come into force with effect on and from the 1st July 1986 i.e. the date from which orders in G.O. 2nd read above were given effect to.

AMENDMENT

In the said order after Para 8 the following shall be added namely:-

" 9 Any amounts drawn in contravention of these rules shall be recoverable in not exceeding 12 easy installments".
