ORDER:

In the Government Order 1st cited above, orders were issued modifying the Automatic Advancement Scheme as recommended by the Pay Revision Commissioner, 2005. In the Circular Memo 2nd cited clarification was issued regarding S.P.P-II/S.A.P.P-II. In the Government order 3rd read above, an amendment was issued to Government Order 1st read above that the service rendered in the categories of Attender and Record Assistant or Roneo Operator put together, as the case may be shall be continued to be reckoned for purpose of Automatic Advancement Scheme.

2. The Government, based on the agreement with the Joint Action Committee of Employees, Teachers and Workers and A.P. Secretariat Employees Coordination Committee, agreed to appoint a Committee for resolution of certain further demands raised by the Joint Action Committee.

3. The Government accordingly, appointed Sri N. Rangachary, Advisor to Government, Finance Department, as Chairman, One Man Committee in the G.O.4th read above with the terms of reference as laid down therein.

4. The One Man Committee submitted its report to the Government. The Government after careful examination of the report, decided to implement certain recommendations of the One Man Committee and accordingly issued orders in the G.O. 5th read above.

5. In the Government Order 6th read above, orders were issued modifying the A.P. Revised Scales of Pay Rules -2005 as recommended by the One Man Committee. As a result of implementing the modified Master Scale and revised segments as recommended by One Man Committee with effect from **1-7-2003** with monetary benefit from **1-4-2005**, the Government hereby issue the following amendments to the G.O.(P)No.241 Finance (PC-II) Department, dated 28-9-2005.

A M E N D M E N T S

1. In Sub-para (a) of Para 2, for the existing pay scale of Rs.10845–22955, the pay scale of Rs.**10845 – 25600** shall be substituted.
 2. In Sub-para (i) of para 4, for the existing Pay Scale of Rs.10845-22955, the pay scale of Rs.**10845 – 25600** shall be substituted.
 3. For the existing Annexure –I, the Annexure – I appended to this order shall be substituted.
 4. For the existing Annexure –II, the Annexure-II appended to this order shall be substituted.
6. The other conditions laid down in G.O.(P)No.241, Finance (PC-II) Department, dated 28-9-2005 shall hold good
7. These orders shall come into force from **1-7-2003**. The monetary benefit shall be allowed from **1-4-2005**. On account of re-fixation, the salary in the Revised Pay scales, 2005 will be paid in cash from the month of June 2006. The arrears if any on account of re-fixation in the Revised Pay Scales, 2005 from **1-4-2005** to **31-05-2006** shall be credited to the General Provident Fund Account of the employees. Those employees who have not opened the General Provident Fund Accounts, they must open General Provident Fund Account, as it is compulsory for every employee. In respect of those employees who do not have G.P.F. Account and who were recruited after **1-9-2004** and are governed by Contributory Pension Scheme, the arrears shall be credited to “I. Small Savings, Provident Funds etc. (b) Provident Funds, 8009 – State Provident Funds, 01 – Civil, M.H. 101 General Provident Funds, S.H. (03) 'Compulsory Savings Scheme” under Public Account.
