**ORDER :**

**A P U S**

In the Government order 1st read above, orders were issued introducing Social Security-Cum-Provident Fund Booster Scheme to provide extra Social Security to the families of the subscribers to the provident fund and positive incentive to State Government Employees. The benefit would be admissible only in an employee has put in at least 5 years service at the time of death. The Accounts Officer in the Office of the A.G.A.P. Hyderabad, will authorize the payment of additional benefit provided in the scheme to the person(s) entitled to receive the provident fund money at the time of taking final payment of the provident fund balances, without further sanction.

2. In the Government order 2nd read above, orders were issued among other things, i.e., enhancement of the rate of interest on the G.P.F. balances and the transfer of the G.P.F. balances now available in Zilla Parishads to the Government account and also maintain the individual accounts as is being done till alternative arrangements are made.

3. As no instructions were issued for the payment of the Booster Scheme, the Director, Local Fund Audit, Hyderabad, Chief Executive Officers, Zilla Parishads have requested for necessary clarification regarding payment of among towards Booster Scheme.

4. The Government after careful examination order the following procedure be followed:

i) According to Para 3(iv) of the Government order second read above the Zillah Parishads shall maintain the individual accounts and hence the Chief Executive Officer, Zilla Parishad, should certify the claim.

ii) The benefit under provident Fund Booster Scheme maybe allowed to be drawn by the Chief Executive Officer, Zilla Parishad only on presentation of bill under Provident Fund Booster Scheme along with sanction order to the audit Officer, Local Fund for Pre-audit, (Substituted Vide G.O. Ms. No. 248 PRE, dated 2-5-1995)

5) The District Treasury Officers are authorized to admit the claim preferred by the Chief Executive Officer, Zilla Parishads from the following head of account. '8338 - Deposits of Local Fund - MH. 104 - Deposits of other Autonomous Bodies - SH(01) -

Deposits of Zilla Parishads out of Provident Fund contributions of Panchayati Raj Employees' to enable the Chief Executive Officers to draw the amount and disburse it to the nominee(s).
