According to the orders issued in the Government order 1st read above. Reader's Allowance is admissible to teachers and lecturers who are visually handicapped to engage Readers to assist them in reading various books so as to maintain professional standards at the following rates

In the Government order second read above, based on the recommendations of Pay Revision Commission, 1999, orders were issued implementing the Revised Pay Scales, 1999 with effect from 1-7-1998 with monetary benefit from 1-4-1999. The Pay Revision Commission, 1999 have also recommended for increase of Reader's allowance by 25%. 3. The Government have accepted the recommendation of the Pay Revision Commission, 1999 and accordingly hereby enhance the existing Reader's allowance as follows :-

| 3. Jr. Lecturers and above | Rs. 375/-p.m. |

4. These orders shall come into force with effect from 1-4-1999 and the arrears from 1-4-1999 to 30-6-1999 shall be credited to General Provident Fund Account of the employees. The enhanced rates shall be paid in cash with effect from 1-7-1999.

5. Necessary amendments to the Andhra Pradesh Manual of Special Pays and Allowances shall be issued in due course.
