**ORDER:**

In the G.O. 1st read above, Government after accepting the recommendations of the P.R.C. 1993 among others, decided to enhance the Educational concession to the children of Non-Gazetted Officers from Rs. 105/- to Rs. 200/- per pupil per annum, uniformly for all the classes I to X for those NGOs who are in the revised scale of pay of Rs. 2600-5580 and below, subject to the condition that the scheme should be limited to two children of the employee with effect from the year 1993-94. The PRC 99 in their recommendations among others recommended for enhancement of reimbursement of tuition fee from Rs. 200/- to Rs. 300/- per pupil per annum upto a maximum of two children.

2. Government, after accepting the recommendations of the PRC 1999, direct that the scheme of reimbursement of tuition fee for the children of NGOs be enhanced from the existing rate of Rs. 200/- to 300/- per pupil per annum, uniformly for all the classes 1 to X, for those NGOs who are in the revised scale of pay of Rs. 5000-10600 and below, subject to the condition that the scheme should be limited to two children of the employee.

3. The enhancement of the above fees applies only where the reimbursement of fee earlier fixed is Rs. 200/- only. In respect of other categories the previous orders issued by Govt. fixing the reimbursement of Rs. 65/- and Rs. 70/- remains the same.

4. The concession of the reimbursement granted in para 2 above is with effect from the academic year 1999-2000.

5. All the Departments of Secretariat and all the Heads of Deapartments are requested to provide additional funds with reference to para-2 above under the relevant Head.s of account under their control either by reappropriation or by obtaining supplementary grant at the appropriate time during the current financial year i.e.. 1999-2000.
