ORDER:

APUS

In the G.O. fourth read above after considering the request of A.P. Government Employees and workers Organization, Telangana N.G.OS Union and A.P. Secretariat Association, Government have decided to enhance the Educational Concession to the children of N.G.Os., from Rs.70/- to Rs. 105/- per pupil per annum, uniformly for all the Classes I to X. This facility is made available for children studying upto graduate level (i.e. from L.K.G./U.K.G. Classes to Intermediate Classes). As per the recommendation of Pay Revision Commission in 1986 this facility was extended to all the employees in the scale of Rs. 1380- 2750 and below. The amount fixed in 1983 has not been revised since then and in the mean while the tuition fees have gone up substantially. So, the Pay Revision Commission, 1993 has recommended that the amount may be enhanced to Rs. 200/- per year to all those in the pay scale of Rs. 2600-5580 and below may be made eligible for the facility besides other conditions remain the same.

2. Government after accepting the recommendations of the P.R.C., 1993 among others direct that the scheme of reimbursement of tuition fee for the children of Non-Gazetted Officers be enhanced from the existing rate of Rs. 105/- per annum per pupil to Rs. 200/- per annum per pupil for those N.G.O's. Who are in the revised scale of Pay of Rs. 2600- 5580 and below subject to the condition that the scheme should be limited to two children of the employee.

3. The concession of the reimbursement granted in Para(2) above is with effect from the academic year 1993-94.

4. All Departments of Secretariat and all the Heads of Departments are requested to provide additional funds with reference to Para 2 above under the relevant Heads of account under tour control either by reappropriation or by obtaining supplementary grant at the appropriate time during the current financial year i.e. 1994-95.
