ORDER

In G.O.Ms.No. 755, Education dated 27-06-1975, orders were issued enhancing the amount of Educational Concession from Rs. 35/- per pupil per annum to Rs. 70/- per pupil per annum. In G.O.Ms.No. 190, Education dated 21-02-1978 orders were issued fixing the rates of the amount to be reimbursed as follows:

2. It has been represented by the confederation of Andhra Pradesh Government Employees and workers Organization, Telangana N. G. O's Union, and A. P. Secretariat Association, that the cost of education including tuition fee of their children in the State has gone up, and that the amount of Rs. 70/- per child per annum now reimbursed is very meager. They have therefore requested that the amount paid by the N.G.O's towards tuition fee of their children may be reimbursed at the rate of Rs. 240/- per annum. This is one of the demands of the N.G.O's in the recent strike. The Demand of the Associations has been reconsidered by Government and they have decided to enhance the Educational Concession to the children of N.G.O's from Rs. 70/- per pupil per annum to Rs. 105/- per pupil per annum uniformly for all classes from Class I to X.

3. This Order will come into force with immediate effect i.e. from the date of issue of this order.

4. All the Heads of Departments are requested to provide additional funds required to cover the expenditure on this account in their Revised Estimates for 1983-84.

5. This order issues with the concurrence of Finance and Planning (EE) Dept., vide their U.O.No. 1414/EE/83, Dt. 23-08- 83.
