**ORDER:**

In the G.O. Ist read above the Govt., have issued orders for revision of Form of Application for Final Payment of General Provident Fund balances. In the G.O.2<sup>nd</sup> read above orders have been issued regarding the authorities competent to sanction Temporary Advance and Part Final Withdrawals.

In his letter 3<sup>rd</sup> cited, the D.T.A.A.P.Hyd. has reported that recently a number of posts of the category of Superintendent, level have been declared as Gazetted but even though the Nomenclature was changed and declared as Gazetted Officers, their Service Rules were not amended by the Government. Further it has been reported by the D.T.A that the process of forwarding the application of the Gazetted Officers for final payment of General Provident Fund through the Head of Department is causing undue delay to the retired employees/Legal Heirs of the deceased employees and requested to issue necessary amendment to the said G.O. accordingly. In the letter 4<sup>th</sup> read above the Accountant General of Andhra Pradesh Hyderabad agreed to the proposed amendment.

3. In the above circumstances, the Government after careful examination of the proposal have decided to issue amendment to the G.O.Ms.No.261, Finance & Planning (Pension.II) Department, dated 28-8-1989 as follows.
