ORDER:

Order on sanction of interest bearing advance to Government servants for their marriage and for the marriage of their sons of daughters were extended by the Govt.in the Panchayat Raj department to their employees in the G.O.2nd read above. The Govt.in the Heath and Muncipal Administration Department however, issued orders in G.O.Ms.No.1026 Muncipal Administration dt30-12-1971. Confirming the need for sanction of marriage advances and commending to the Muncipal Councils to adopt the order issued by the Government in the Finance & Planing Department after satisfying themselves that their financial postion will permit them to do so in otherwords each muncipal council was given the discretion to adopt the scheme in respect of their employees. subsequently, in the G.O. Ms.No.96, Finance & Planing (A&L) Department, dt.08-04-1975, the Govt.enhanced the amount of interest bearing advances for marriages and also increased the number of instalments for the repayment of the said advance as follows.

- i) Intrest bearing advances for the marriage of Govt.servants or the marriage of their sons of daughter may be sanctioned.
 - ii) Upto 15 months pay, subject to a maximum of Rs.3,000/- for the marriage of female Govt.Servant or a daughter of Government servant.
- b). Upto 15 months pay, subject to maximum of Rs.1,500/- for the marriage of a male

Govt.servant or son of Govt.servant.

ii). The advance is repayable in eighty equal instalments.

2. In G.O.Ms.No.347 Panchayat Raj (Est.III), dt. 2-7-75 order were issued extending the application of G.O.Ms.No: 96 Finance & Planning, dt.08-04-1975 to the employees of Panchayat Samithis and Z.Ps.subject to the following conditions:-

i) The expenditure shall be met by the Z.Ps/P.Samithis from their general funds.

ii) Z.Ps/P.Samithis will provide necessary funds in the budget.

iii). Zilla Parishads – P.Samithis shall determine the amount of advance that has to be sanctioned in each case and accord sanction following the rules prescribed in the G.O.Ms.No.359 Panchayat Raj.dt.25-06-1970.

3. The Federation of A.P. Teachers organization have represented that the facilities of sanction of marriage advances which is available to the teachers of Govt.schools and for employees of local bodies may be extended to the teachers of non-Government schools.'

4. the Government after careful consideration direct that (i) the teachers of schools under local bodies ie., Z.Ps,P.Samithis shall be granted interest bearing advances for their marriage and the marriage of their sons and daughters on the following terms and conditions applicable to the other employees of the respective local bodies.

1.a. Upto 15 months pay subject to a maximum of Rs.1,500/- for the marriage of a male teacher or son of a teacher.

2. The marriage advance is repayable in eighty instalments.

3. The interest on the advance is payable on complete repayment of the advance the prescribed rates.

4. The expenditure will be met by the Z.Ps/P.Samithis from their general funds.

5. The Zilla Parishad / P.Samithis shall determine the amount of advance that has to be sanctioned in each case, and accord sanction following the rules if any prescribed in that regard, in the case of their employees.

ii. The teachers of school under Municipalities will be also eligible for marriage advances on par with the other employees of the municipal councils in terms of G.O.Ms.No.1026 Municipal Administration dt.27-12-71 and that,

iii. In both the cases (i.e.,) teachers of schools under Z.Ps and P. Samithis and municipal councils, the local bodies will not be eligible for any Govt. grant for the purpose of sanction of marriage advance.
