to

that of Language Pandits Grade -1 - Fixation of pay under F.R. 22-B -
Instructions - Issued.

In the G.O. 1st cited, it was ordered to upgrade the language pandits
Or. 11. who were holding the qualification equivalent to the language pandits
Grade - I, to that of Grade - 1, Language Pandits in the scale of Rs. 700-1200
and to fix (heir pay under P.R. 22 (a) (ii). Subsequently in (he G.O. 1st cited,
to fix the pay of upgraded Language Pandits Grade - 1 under F.R. 22 (a) (i)
instead of F.R. 22 (a) (ii).

2. In the reference 3rd cited the Pandilha Parishad alleged that the fixation of
pay of upgraded Language Pandits Grade - 1 was done by [he District-Educational
Officer, Warangal under F.R. 22-B. But the audit officer local funds, Warangal
objected the fixation of pay under F.R. 22-B. The upgraded Language Pandits Gr. - 1
approached the Tribunal and the Tribunal ordered that the District Educational
Officer, Warangal is in order. Similarly, other institutions-were also obtained-
directions from Tribunal to this effect and got fixation of pay done under F.R. 22-B.
The Parishad, therefore, urged the Government to consider for issue of general

instructions in the matter rather to compel the upgraded Language Pandits Gr. 1 to approach to the Tribunal and get the directions to this effect.

3. After detailed examination of the request of the Panditha Parishad it has been decided to issue general instructions allowing fixation of pay under F.R. 22^B to all the upgraded Language Pandits Grade I.

4. , Government, therefore, issue instructions that the upgraded Language Pandits - 1 in the scale of Rs. 700-1200 shall be allowed fixation of pay • under F.R. 22-B. as per the orders in vogue.
