ORDER :

In the G.O. 8th read above, orders have been issued allowing that where the pay of a Government employee in the Special Grade Scale as fixed in the Revised Pay Scales, 1993 is equal or less than the pay Fixed in the Ordinary Grade scale in the Revised Pay Scales, 1993 to fix his pay in the higher post at the stage next above the pay fixed in the Ordinary Grade Scale on the analogy of Rule 6 (g) (i) of the A.P. Revised Scales of Pay Rules, 1993 and to regulate the pay under P.R. 31 (2) on the date of next increment.

2. It has been brought to the notice of Government that in some cases the pay fixed in the Special Promotion Post-I/Special Adhoc Promotion Post-1 of Revised Pay Scales, 1993 is equal/less than the pay fixed in the Special Grade Scales and so also the pay fixed in the Special Promotion Post-II/Special Adhoc Promotion Post-11 is equal/less than the pay fixed in the Special Promotion Post-I/Special Adhoc Promotion Post-1 and requested to extend the orders issued in G.O. 8th read above to cover such cases also.

3. The Government after careful consideration hereby order that where the pay of a Govt. employee in Special Promotion Post-I/Special Adhoc Promotion Post-1 scale as fixed in the Revised Pay Scales, 1993 is equal or less than the pay fixed in the Special Grade Scale in the Revised Pay Scales, 1993 and also where the pay of a Government employee in Special Promotion Post-II/Special Adhoc Promotion Post-11 scale as fixed in Revised Pay Scales, 1993 is equal or less than the pay Fixed in Special Promotion Post-I/Special Adhoc Promotion Post-1 scales in Revised Pay Scales, 1993, his pay in the higher post shall be fixed at the stage next above the pay fixed in the lower post i.e.. Special Grade/Special Promotion Post-I/Special Adhoc Promotion Post - I. The pay on the date of next increment in the Special Grade/Special Promotion Post-I/Special Adhoc Promotion Post=I as the case may be in the Revised Pay Scales, 1993 shall be regulated under F.R. 31 (2).

4. These orders shall take effect from 1-7-1992 with monitory benefit from 1-4-1993.
