FUNDAMENTAL RULES - Fixation of pay on promotion to higher post -Further orders - Issued.

ORDER:

In the order read above, instructions were issued regarding the fixation of pay of Government servants on promotion to a higher post. Consequently the provisions of the Fundamental Rules and Hyderabad Civil Service Rules were amended. These orders have come into force from the date of issue of the GO. read above and apply to Government servants who are promoted to higher posts on and after 23-8-1983.

2. The various Services Associations have represented to Government that the orders issued through the GO. read above may be given effect from 25th December, 1982 or which date the proposal was agreed to in principle, in a meeting between the chief secretary and the representatives of the Joint Council of Associations and Unions.

3. Government have carefully considered this question and have decided to give retrospective effect to the orders contained in the GO read above, from 25th December, 1982 with monetary benefit from 23rd August, 1983. Government have also decided that the option contemplated by the last paragraph of Ruling (ii) under the new rule 22-B of Fundamental Rules/rules 35-A of H.C.S.Rs., shall be exercised within a period of two months from the date of this order Option thus exercised shall be final.

4. To give effect to this decision, the following amendments are issued.

NOTIFICATION - I

In exercise of the powers conferred by the proviso to article-309 of the Constitution of India and of all other powers hereunto enabling, the Governor of Andhra Pradesh hereby makes the following amendment to the Fundamental Rules, namely: -

In the same rules, to rule 22-B the following Note shall be added at the end, namely: -

"Note: The provisions of this rule shall be deemed to have come into force on the 25th December, 1982 and shall apply to the Government servants who have been promoted on or after that date. The monetary benefit arising out of such pay fixation shall however be allowed from the 23rd August, 1983",

NOTIFICATION - II

In exercise of the powers conferred by the proviso to article-309 of the Constitution of India and of all other powers hereunto enabling, the Governor of Andhra Pradesh hereby makes the following amendment to the Hyderabad Civil Service Rules, namely:

In the said rules, to rule 35-A, the following Note shall be added at the end, namely: -

"Note: The provisions of this rule shall be deemed to have come into force on the 25th December, 1982 and shall apply to the Government servants who have been promoted on or after that date. The monetary benefit arising out of such pay fixation shall however be allowed from the 23rd August, 1983".
