Sub:- Drawl of anticipatory pension / gratuity certificate to be produced by the Pensioner – amount to note 3 under rule 51 of A.PO revised pension rules 1980 – orders.

The Director of Treasuries and Accounts, Andhra Pradesh Hyderabad in the reference read above has stated that as per the present system, the pension disbursing authorities i.e., solo – Treasury officer / assistant pension payments officers have to in sits for non – draw certificate before payment of pension / gratuity from the pensioner by the drawing officer where the retired employee i.e., pensioner last worked. If the pensioner produce the certificate on his appearance for drawing the pension the sub treasury officer / assistant pension payment officer have to make payment on the strength of the certificate as such the pension disbursing authority do not have any specimen signature of the certificate issuing authority i.e. at the station where the pensioner last worked. Due to this, it is very difficult to ascertain whether the certificate is genuine or not.

To avoid any bogus payments of pension on bogus non drawl certificate regarding anticipatory pension gratuity it is proposed to insist the counter signature of the grasser office / assistant pay accounts officer concerned on the certificates to be proposed by the pensioner.

Government after careful consideration, have decided to issue amendment to note 3 under rule – 57 of Andhra Pradesh Revised pension rules 1980.

Accordingly the following notification will be published in the Andhra Pradesh gazette.

NOTIFICATION

In exercise of powers conferred by the proviso to article 309 of the constitution Df India and all the powers here into following amendments to the rule 51 Andhra Pradesh revised pension rules, 1980 issued in G.O.(P) No.88, finance and planning department dt.26th march 1980 as amended from time to time.

AMENDEMENT

In the said rules in rule 51

In the heading (b) family pension for note 3 the following shall be substituted namely

Note 3: The pensioner of family pensioner will have to produce a certificate from the head of officer duly countersigned by the audit authorities i.e. treasury office or pay and accounts officer (if the payment is in a different district it may be got countersigned by the district treasury officer or pay and accounts officers showing whether he / she has drawn any anticipatory pension / family pension and if so for

what period it has been disbursed the head of office shall stop payment of the anticipatory pension once he issued such certificate.

Under the heading (C) sanction of anticipatory gratuity after provisions the following note shall be added.

Namely:

Note: The pensioner / family pensioner will have to produce a certificate from the head of officer duly countersigned by the audit. Authorities i.e, treasury officer or pay and accounts officer (if the payment is in a different district it may be got counter signed by the district treasury officer or pay and accounts officer) showing whether He / She has drawn any anticipatory gratuity and if so for what period it has been disbursed. The head of office shall stop payment of the anticipatory gratuity once he issues such certificate.
