- ❖ Orders were issued in the G.O.1st cited that in respect of cases where entitlement of family pension was not record on the pension payment order. The treasury officer / pension payment officer have to obtain necessary documents like joint photos, descriptive rolls etc., of the family pension beneficiary and forward the same to accountant general A.P., Hyderabad to authorize family pension instructions were also issued vide reference 2nd cited in continuation of the said G.O. to all the sub treasury officers/pension payment officers to communicate the revised family pension fixed by them with reference to the G.O.1st cited to the eligible pre 01-04-1978 pensioners in the format prescribed and annexed to it instructions were also issued vide reference 3rd cited to hand over pensioner's pertain of PPO of Pensioners. Further according to Para 5.2 in appendi-x-1 of the G.O.4th cited, the pensioner half of the PPO shall be returned to the pensioner treating is as the property of the pensioner.

- ❖ State pensioners, central association Hyderabad in the reference 5th cited represented to issue instructions to communicate the revised family pension that would be payable to the family which was consolidated from time to time.
- ❖ Orders were already issued in G.O.(p)No.75 Finance and planning(Fw-PeNo1) Department dated 07-03-1987 G.O.(P)No.303 finance and planning (FW.Pen1) department dated 02-09-1984 G.O.(P)No.156 Finance and planning (FW-Pen1) Department dated 16-09-1999. In which consolidation of pensions were ordered that at the time of nothing revised consolidated pension of the PPO the disbursing corresponding revised consolidated enhanced family pension disbursing consolidated normal family pension on the pension payment orders. Similarly in case where enhanced.
- ❖ Family Pension is being paid. The normal family pension to be payable in future would also be consolidated and noted on the pension payment orders.
- ❖ In the above circumstances, the director of treasuries and accounts, A.P. Hyderabad and the joint Director / Pension payment officer, A.P. Hyderabad are directed to issue instruction to all pension disbursing authorities under their control to follow the above instructions and update the pension payment orders of the pensioners portion also and hand over the same to them they should submit compliance report within a month in this regard.
