**ORDER :-**

**A P U S**

In GO Ms No. 1154, Education, dt. 21-11-73 orders were issued that the temporary teachers working in Panchayat Samithis and Z.Ps. should be specially interviewed by the DSC and the selected teachers regularized, following the rules or reservation and that the interviews should be restricted to those who were in service on a temporary basis with one year service with or without breaks as on 1-10-73. In Para 5 of the said GO the procedure to be followed for the conduct of selection and test etc., by the DSC. has also been prescribed.

Representations have been received that the DSC, West Godavari conducted interviews and selected the candidates who have put in service or one year and more and also the fresh candidates leaving the in-service teachers who have put in less than one year service and the non selected in service teachers were ousted. Govt. after examining the representations issued orders an G.O. Ms No. 389, Education, dt. 27-4-71 that the service of the temporary teachers employed in Z.Ps. and P. Samithis be regularized without going through the process of selection by the D.S.C. by exempting them under rule 1-A of the rules relating to the constitution of the D-S.C As per the orders issued in G.O. Ms No. 1154, Education, dt. 21-11-73 arid GO Ms No. 389 Education, dt. 27-4-74, the teachers who have put in over one year service as on 1-10-73 have to appear for a special interview for getting their services regularized, whereas the teachers who have put in less than one year service need not appear for any interview and their services have to be regularized by relaxing rule 1-A of the D.S.C. rules. In effect the teachers who have put in more service have to appear before the D.S.C. and the teachers who have got less

service will regularized by relaxation of rules. This procedure appears to be anomalous. Further the orders are applicable to the candidates who were in service as on 1-10-73 and not recruited subsequently.

The Govt. after careful examination of the entire question afresh, hereby direct that all the teachers who are in service as on 1-10-75 shall be allowed to appear for special interviews of the D. S. Cs. to regularize their services. The non Selected individuals shall appear again in the succeeding

D.S.C interviews to get the selves selected and regularly appointed.

The D.S.Cs are requested to take immediate action to conduct interviews after giving wide publicity so that the temporary teachers any avail themselves of this opportunity and have their services regularized.

The receipt of this order should be acknowledged.
