Education - Regularization of services of teachers appointed prior to 1-10-75 who need not appear before the District Selection Committees vis-a-vis teachers' appointed on or after 1-10-75 and up to 16-4-79 who go before and got selected by the D.S.C. - Orders - Issued.

**ORDER:**

**A P U S**

Orders have been issued in G.O. Ms. No; 411, Education, dt. 17-4-79 to the effect that the teachers appointed temporarily in the schools under Z.Ps. and P. Samithis prior to 1-10-75 and who are fully qualified but not selected by the D.S.Cs. till the date of the order, shall be absorbed into the concerned district cadres, without the process of selection by the D.S.Cs. under rule I-A of the rules issued in the A.P. P. Samithi and Z.Ps- Act. 1959 These orders were issued with a view to avoid hardship to the in service teachers appointed prior to 1-10-75. The Collectors and special officers were also requested to submit proposals in all such cases to the Govt. for issue of orders in individual cases.

2. Orders were also issued in the G.O. 1st read above that special interviews shall be conducted for the teachers appointed on or after 1-10-75 by the respective District Selection Committees allowing them two successive chances from the date of the order to get selected for regular appointment.

3. In G.O. Ms. No: 414, Education, dt. 17-4-79 the Govt. simultaneously, imposed a ban on further recruitment of teachers on temporary basis even through the media of Employment Exchanges by the authorities of the Z.Ps. and P. Samithis.

4. In G.O. Ms. No: 744, Education, dt. 10-8-79 the Govt. clarified that the regularization of the services of the in-service teachers who are selected by the D.S.Cs.

shall be made in the orders indicated by the D.S.Cs. and from a date subsequent to the date of regularization of the services of the last candidate in the respective categories in the previous panel or the date of appointment whichever is later.

5. In view of the position stated in paras 1 to 4 above, it has become necessary to Issue orders in regard to the dates from which the services of teachers appointed prior to 1-10-75 and who are not required to go before the D.S.Cs. for selection for regularization of their services vis-a-vis the dates of regularization of services of teachers appointed on or after 1-10-75 and up to 16-4-79 who go before the D.S.Cs. at the special interviews and get selected. Keeping in view the general principles laid down in G.O. Ms. No: 742, Education, dt. 10-8-79, the Government issue the following orders for the regularization of the service of the teachers appointed prior to 1-10-75 and not required to go before the D.S.Cs. vis-a-vis those appointed on or after 1-10-75 and up to 16-4-79 and selected by the District Selection Committees:

i) In exercise of the powers conferred under Rule-I-A of the rules relating to the constitution of selection committee for the post included in the District cadres issued under the A.P.P. Samithis and Z.Ps.Act, 1959, the Government direct that the services of the in service teachers appointed prior to 1-10-75 shall be regularized from a date following the date of regularization of services of the last candidate in the respective category of the teacher who got selected by the D. S. C. at the selection held before 17-4-79.

ii) The regularization of the service of the in service teachers appointed on or after 1-10-75 and up to 16-4-79 who are selected by selections after 17-4-79 shall be made in the order indicated by the D. S. C. and from a date subsequent to the date of regularization of the services of the last in service candidate in the respective category appointed prior to 1-10-75 in terms of (i) above or the date of appointment whichever is later. In other words, if in a particular category of teachers, a candidate who was selected by the D.S.C. at the selection held before 17-4-79 as appointed regularly say, from 2-5-79, an in service teacher appointed prior to 1-10-75 shall be eligible for regularization of his services from 3-5-79 and an in service teachers appointed after 1-10-75 and before 16-4-79 and selected by the D.S.C. shall be eligible for regularization of his services from 4-5-79.

6. The Special Officers of the Z.P. and P. Samithis shall take up immediately if not already taken up the regularization of the service of the teachers appointed prior to 1-10-75 in the first instead teachers appointed same. The regularization of services of teachers appointed on or after 1-10-75 and upto 16-4-79 shall be taken up only thereafter.
