It has been brought to the notice of Govt. that for want of reports from the Police authorities regarding the verification of antecedents of teachers appointed by the Z.Ps, the declaration of probation of teachers etc-, is being held up causing much inconvenience to the teachers. The Deputy Inspector General of Police, Hyderabad in his letter 4th cited has reported that the ZP authorities are calling for reports of the verification of character and antecedents of the selected candidates at the time of regularization of their service and not before their appointment . He has requested to issue instructions to avoid such irregularities which may create an embarrassing situation. In the zonal conference on education held at Kurnool during May, 1972, recommended that for the receipt of police reports an respect of candidates selected by the DSCs a time limit of 6 weeks may be prescribed and if the reports are not received within that time, action to regularize the services of teachers may be taken by the local bodies.

2. The matter has been examined in consultation with the DPI, Hyderabad According to rule 12(3)(ii) of the Rules relating to the establishment under P. Samithis and ZPs issued in GO Ms No. 936, Planning and Local Administration, dt. 17-7-62 the verification of antecedents of teachers is necessary for the regularization of services of the incumbents employed in P. Samithis and ZPs. Similarly, according to rule 9(3)(ii) of the rules relating to the establishment under Municipal councils issued in GO. Ms. No. 2342, LSG, dt. 2-6-36 of the Madras composite state, the verification of antecedents of the incumbents employed in Municipal councils is necessary. According to the instructions issued in Para 4(a)(iii) of Govt. Memo No: 3588/SC-A/69-14 General Administration (SC-A) Department, dt. 17-5-73, regarding the verification of character and antecedents of candidates for employment in public services, the police authorities should complete the verification of antecedents of the candidates selected for employment in public services with in fortnight and if no report regarding the

verification of antecedents is received from the police within the given time of fortnight, and if no intimation regarding extension, of required time for completing the Verification is received from the police authorities it has to be assumed that there is nothing adverse against the candidate and action taken to appoint him on that assumption after verifying from the police authorities that no adverse report has been sent The Inspector General of. Police, Hyderabad is requested to follow the instructions issued in Govt. memo No. 3588/Sc-A/69-14, GeneralAdministration (Sc.A) Department, dt. 17-5-73 for .verification of the antecedents of teachers working under ZPs and Municipalities also.
