ORDER:

In the G.O.s second and fifth read above, orders were issued providing 3% reservation for the persons with disabilities and earmarking the 6th, 31st and 56th Roster points among the Visually Handicapped, Hearing Handicapped and Orthopedic ally Handicapped persons respectively. . Further, in the G.O. seventh read above, order were issued indicating the roster points in the second and subsequent cycle of 100 points for reservation in favour of persons with disabilities providing carry forward syste and for interchanging among the women/men disabled categories.

2. Accordingly, the following notification will be published in the Andhra Pradesh Gazette.

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and of all other powers hereunto enabling the Governor of Andhra Pradesh hereby makes the following amendments to the Andhra Pradesh State and Subordinate Service Rules, 1996, issued in G.O.Ms. No. 436. General Administration (Ser.D) Department, dated the 15th October, 1996 and published part -1 Extraordinary Issue of the Andhra Pradesh Gazette dated the 27th January 1997, as amended from time-to time.

2.The amendments hereby made shall be deemed to have come into force with effect from 27th November, 2003. -

AMENDMENTS

In the said rules in clause (e) to sub-rule (2) of rule 22, (1) For the existing order of rotation points 6th ,31st, and 56th, the following shall be substituted, namely.

(2) In the proviso, for the item (ii) the following shall be substituted namely.

"(ii) In the second cycle of 100 roster points the following points shall be reserved as follows:

In the third cycle of 100 roster points the following points shall be reserved as follows

The 6th, 31st, 56th points in each cycle of 100 vacancies shall be allotted to the Visually Handicapped, Hearing Handicapped, and Orthopaedically Handicapped, persons respectively stated above and where qualified and suitable candidates are not available from among them, the turn allotted for them in the unit referred to above shall be carried forward for three succeeding recruitment years. In the third succeeding recruitment year, if Disabled candidates from any category are not available for appointment in the turn allotted, the vacancy shall be filled by next group of disabled in rotation by effecting interchange and the reservation shall cease thereafter."
