ORDER:

In the Government Order 2nd read above, orders have been issued that such of the employees who had actually officiated in higher posts prior to 1-7-1986 in regular capacity, but who stood reverted to the lower post on the crucial date of 1-7-86 for want of vacancies who were re-promoted to the higher posts on or before 30-6-1987 shall also be allowed the benefit of fixation of pay in the Revised Pay Scales of 1986. Accordingly, the following amendment is issued to the A.P. Revised Scales of Pay Rules, 86. The following notification will be published in the Andhra Pradesh Gazette:

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Andhra Pradesh hereby makes the following amendment to the Andhra Pradesh Revised Scales of Pay Rules, 1986.

This amendment shall be deemed to have come into force with effect from the 1st July, 1986.

AMENDMENT

In rule 5 of the said rules after clause (ii) of sub-rule (g), the following clause shall be added namely:

"(Hi) Where a Government employee, who had actually officiated in higher post prior to 1-7-86 in regular capacity, but who stood reverted to the lower post on the crucial date of 1-7-1986 for want of vacancy and who was re-promoted to the higher post on or before 30-6-1987 shall be allowed the benefits of fixation of pay in the Revised Pay Scales, 1986. The pay fixation, monetary benefit etc., in these cases shall be as indicated below:

(1) The employee should have held the post prior to 1-7-1986 in regular capacity and stood reverted to the lower post on that date for want of vacancy.

(2) On subsequent appointment to that post after 1-7-1986 the employee should draw pay in the Revised Pay Scales, 1986.

(3) pay in such cases, shall be fixed in the Revised Scales of 1986 in accordance with the principles laid down in proviso to Fundamental Rule/Rule 34 of Hyderabad Civil Service Rules notionally treating the employee to have held the higher post on 1-7-1986 and elected the Revised

Scales of pay from the date. In other words the employees should have deemed to have held the post in question on 1-7-1986 and elected the Revised Scales from 1-7-1986 only.

(4) The pay in the Revised Scales shall be fixed in accordance with the principles of pay fixation laid down in these rules on the basis of the pay which he would have drawn in the pre-revised scales had he been holding that post on 1-7-1986.

- (5) The subsequent increments shall be allowed in accordance with the rule 6 of the A.P. Revised Scales of Pay Rules, 1986.
- (6) The monetary benefit shall be allowed from the date of their actual promotion.
- (7) Where the pay of such employee on re-promotion to the higher post after 1-7-1986 happens to be less than what would be admissible at the stage next above his substantive pay in the lower post on the date of such re-promotion, his pay in the higher officiating post shall be fixed at the stage next above his pay in the lower post.
