ORDER:

The Pay Revision Commissioner, 1986 who has reviewed the exiting system of Transfer traveling Allowance has recommended.

1. Payment of Transfer Traveling Allowance to dependent parents of the Gazetted Officers.
- 2.(i) Payment of packing and unpacking charges for the transfer outside the State at the rates available to the Central Government employees.  
(ii) Payment of packing and unpacking charges for the transfer outs? i.e. the zones.  
(iii) Payment of packing and unpacking charges for the transfers within the zones.
3. Payment of disturbance allowance (Lumpsum Transfer Grant)
4. Payment of transport charges for personal effects.
5. Enhancement in the mileage where two points are not connected by train or one end is not connected by train.

The Government after careful consideration have accepted the recommendations of Pay Revision Commissioner including those relating to transfer traveling allowance and hereby orders as follows:

The classification of Officers into grades shall be as indicated below:

Grade of Officers

|           |                            |
|-----------|----------------------------|
| Grade I   | Rs.2690-4440 and above     |
| Grade II  | Rs.1330-2630 and above but |
| Grade III | Rest of the employees      |

**Dependent parents of Gazetted Officers**

The definition of 'Family' in Clause (iii) of Rule 2 of Andhra Pradesh Traveling Allowance Rules and Notes (i) and (2) there under shall continue to apply.

However, in the case of Gazetted Officers, 'Family' shall include, their parents also in case they are wholly dependent on the Officer. This will apply only for Transfer Traveling Allowance.

Packing and Un-packing charges:

i) In the case of transfer outside the State, the employees shall be eligible for the following charges: -

a) Grade-1 Rs.1200-00

However, incumbent drawing pay of Rs. 5100/- or above shall be allowed Rs. 1500/-.

b) Grade-11 Rs.900-00

c) Grade-111 Rs.600-00

ii) In the case of transfer, within the State, but outside the zone, the employees shall be eligible for the following charges:-

a) Grade-I Rs.150/- at each end

b) Grade-II Rs.100/- at each end

c) Grade-III Rs. 75/- at each end

iii) In the case of transfer, within the zone in the State, the employees shall be eligible for the following charges:-

- a) Grade-I Rs.75/- at each end
- b) Grade-II Rs.50/- at each end
- c) Grade-III Rs.35/- at each end

#### Disturbance Allowance or Lumpsum transfer Grant

In the case of Transfers to Delhi and places outside the State, the employees shall be eligible for the following amounts as Disturbance Allowance:-

- a) Grade-I R.3000/- However, incumbents drawing pay of Rs.5100/- or above shall be allowed Rs.4000/-
- b) Grade-II Rs.1500-00
- c) Grade-III Rs. 600-00

Note: This is a one time payment.

#### Charges for Transport of Personal Effects:

i) In case the personal effects are transported by goods train employees shall be eligible for actual expenditure, subject to the maximum indicated below:-

- a) Grade-I 50 Quintals
- b) Grade-II 40 Quintals
- c) Grade-III 30 Quintals

Note: (1) For this purpose, they must produce the receipts.

Note: (2) If a Government servant carries his personal effects by passenger train or by air instead of by goods train, he may draw the amount which would have been admissible had he taken the maximum number of kilograms by goods train.

Note: (3) Subject to the prescribed maximum number of kilograms a government servant may draw the actual cost of transporting /personal effects to his new station from a place in India other than his old station(e.g. from a place where they are purchased enroot or have been left on the occasion of a previous transferor from his old station to a place in India other than his new station, provided that the total amount drawn, including the cost of transporting those personal effects shall not exceed that admissible had the maximum admissible number of kilograms been transported by goods train from the old to the new station direct.

Note: (4) The cost of transportation of personal effects on transfer may be allowed. Subject to the maximum quantity prescribed above at the "Quick Transit Service" rates, if personal effects are actually transported by the "Quick Transit Service" rates, a certificate to the effect that personal effects are actually transported by the "Quick Transit Service" and that they reached the destination within the specified period should be recorded by the claimant on the Traveling Allowance Bill.

Note: (5) A Government servant carrying goods by road between places connected by rail can draw actual expenditure on transportation of personal effects by road or the amount admissible on transportation by railway by goods train whichever is less.

Note: (6) In case the personal effects are transported by other modes of transport like lorry etc., the existing rules mentioned in Andhra Pradesh Traveling Allowance Rules and orders issued from time to time shall continue to apply, except as provided for in this order.

#### Rates of Mileage

The rates of 'mileage, shall be as follows:

- a) Grade-I Rs.1-50 per K.M.
- b) Grade-II Rs.1-25 per K.M.
- c) Grade-III Rs. 1-00 per K.M.

Note (I): There will not be any distinction between Class-IV and other employees in respect of the benefits admissible for Transfer Traveling Allowance.

Note (2): In respect of journey by road all employees will draw twice the mileage. In addition the employees may also draw one extra mileage, if three members of his family accompany him and another extra mileage, if more than three members of his family accompany him.

Note (3): The rates of mileage given in this paragraph will also apply to journeys on tour.

3. These orders will come into force with immediate effect.

4. The claims already settled otherwise need not be reopened. Claims which are not preferred but are pending shall be admitted in audit in accordance with the above orders. Application of these orders to officers of A. I. S. and employees drawing paying the A. P. Revised pay Scales. 1986.

5. In so far as officers belonging to All India Service who are in Central Scales of pay and the employees drawing the three Man Committee scales (A. P. Revised Pay Scales of 1976) the classification of grades shall be as follows:-

- a) Officers of All India Service in Junior Time Scale shall come under Grade-11 under these orders.
- b) Other officers belonging to All India Service shall come under Grade-1 under these orders.
- c) Employees drawing pay in the scale of Rs. 700-1600 in the A. P. Revised Pay Scales of 1976 shall come under Grade-11 under these orders.
- d) Others drawing pay in the scale above Rs. 700-1600 in the A.P. Revised Pay Scales of 1976 shall come under Grade-1 under these orders.

6. Necessary amendments to the Andhra Pradesh Traveling Allowance Rules shall be issued in due course.
