Consequent on the constitution of the Pay Revision Commission and the appointment of the Pay Revision Commissioner, various Service Associations have been requesting for sanction of Interim Relief pending recommendations of the Pay Revision Commissioner and the decision of the Government thereon. Government, after careful consideration, hereby sanction Interim Relief of 11% (eleven percent) of Basic Pay [Pay as defined under F.R. 9(21) (a) (i)] with effect from 1-6-1998, subject to following conditions:

1. The Interim Relief sanctioned above shall be shown as a distinct element of remuneration which shall be adjusted against any benefit that may accrue to the employees on account of revision of scales of pay and other allowances as a result of Government's decision on the Report of the Pay Revision Commissioner.

2.The Interim Relief shall be applicable to all Government employees, employees of Local Bodies, Teaching and non-Teaching staff of Zilla Parishads, Mandal Parishads, Gram Panchayats, Municipalities, Municipal corporations, Zilla Grandhalaya Samsthas, Agriculture Market Committees, teaching and non teaching staff of aided schools, junior Colleges and Degree Colleges and non-Teaching staff of all Universities including Acharya N.G. Ranga Agricultural University, Jawaharlal Nehru Technological University and Regional Engineering College, Warangal drawing Pay in the A.P. Revised Pay Scales of 1993 and Work charged establishment who get monthly pay in a regular scale of Revised Pay Scales 1993.

3.The payment on account of Interim Relief involving fractions of fifty paise and above shall be rounded off to next rupee and fraction of less than fifty paise shall be ignored.

4.The Interim Relief will not be admissible to the officers of the A.P. Higher judicial Service and A.P. Judicial Service. The Interim Relief will also be not admissible to the Teaching staff drawing A.P. Revised UGC Scales of Pay 1986/AICTE Scales 1986 and ICAR Scales 1986.

5.The Interim Relief will not be admissible to the Contingent Establishment including Part Time Contingent Establishment.

6.The Interim Relief shall be payable from the month of June, 1998.

7. The Interim Relief sanctioned above shall not count for computation of Dearness Allowance, House Rent Allowance, City Compensatory Allowance or any other allowances, Encashment of Leave, Pay Fixation, Pension or Gratuity etc.

8. The expenditure on sanction of Interim Relief will be debited to the relevant Salary Head of Account. All the Departments of Secretariat and Heads of Departments are requested to take prompt steps to provide additional funds under relevant Heads of Accounts.
