ORDER:

According to Rules 4(3) of the A.P. Public Employment (HRA) Rules. 1985 issued in G.O. first read above, employees working in total areas and who are entitled for rent free quarters under the relevant orders and who have not been provided with such quarters are entitled to Additional H.R.A. at 20% of pay subject to a maximum of Rs 300/- per Month in the case of Class –II Agency areas and at 25% of pay subject to a Maximum of Rs. 375/- per month in the case of Class I Agency Areas.

With a view to nationalize/restructure special Allowance the Government has constituted a High Power Committee in the G.O. 2nd read above the Chairmanship of the Then Commissioner for land Revenue. The High Power Committee submitted its Report to the Government on 10th December,1990. In the G.O. 3rd read above the Government Constituted a cabinet Sub-committee to Examine the Recommendations of the High Power Committee on special allowances. The Cabinet sub-Committee examined the Reports of the High Power committee and also Held discussions with representatives of services Associations, Government have considered all aspects of the matter and have taken decisions regarding the pattern of special Allowances to be implemented with effect from 1-12-1991. A Memorandum of understanding has also been signed between the Government and the representatives of the said Associations, in respect of the issues on which there was a common understanding.

3. After careful consideration of the report of the High Power Committee. Government have decided to make certain readjustments in the allowances for employees working in the Scheduled areas in order to correct certain distortions. Accordingly Government Have issued orders in the reference 4th cited regarding the payments of special compensatory/Allowance at new slab rates as well as payment of Additional House Rent Allowance in lieu of Rent free quarters in the scheduled areas.

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and of all other powers hereunto enabling the Government of Andhra Pradesh here by makes the following amendment to the A.P. Public Employment (HRA) Rules, 1988.

AMENDMENT

In Rule 4 the following shall be submitted for sub-Rule (3) Employees who are working in the scheduled areas and are entitled to Rent Free Quarters, Shall be eligible to draw the allowance at the rates specified in sub Rules (1),(2) and (3) of Rule 2. They shall also be eligible to draw Additional HRA at 10% of pay subject to a maximum of Rs 150/- per Month

The amendment shall be deemed to have come into force with effect from 1st December ,1991.
