**ORDER :**

In the Government Order first read above, orders were issued revising the pay scales of the State Government employees from 1.7.1998 with monetary benefit from 1.4.1999. According to proviso (ii) to Rule 6(c) of the Andhra Pradesh Revised Scales of Pay Rules, 1999, while fixing the pay in Revised Pay Scales, 1999, if the amount of emoluments is more than maximum of the Revised Pay Scales, 1999 the pay shall be fixed at the maximum of the scale, the difference being treated as personal pay. These orders are silent about regulation of this personal pay.

2. In the reference 2nd read above, the Pay and Accounts Officer, Hyderabad has brought to the notice of the Government that during the scrutiny of the claims under item(ii) of the proviso to rule 6(c) of the Andhra Pradesh Revised Scales of Pay Rules, 1999, a doubt has arisen in regulation of this personal pay as to whether the personal pay specified therein has to be absorbed in future stagnation increments or to continue as such.

3. The Government has examined the matter carefully and hereby order that if the pay of an employee is fixed in Revised Pay Scales, 1999 under item(ii) of the proviso to rule 6(c) of the said Rules, 1999 exceeds the maximum of the revised scales, the difference between the maximum of the revised pay scales and the pay so fixed shall be treated as personal pay to be absorbed in future increases in pay on promotion or in future revisions.

The following notification will be published in the Andhra Pradesh Gazette:

**NOTIFICATION**

1. In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Government of Andhra Pradesh hereby makes the following amendment to the Andhra Pradesh Revised Scales of Pay Rules, 1999.

2. The amendment hereby made shall be deemed to have come into force with effect from the 1st July, 1998.

**AMENDMENT**

In the said rules, in rule 6, in clause (c), in the proviso to item(ii) the following shall be substituted, namely:-

(ii) if the amount of the existing emoluments as so increased under clause (a) is more than the maximum of the Revised Pay Scales of 1999, the pay shall be fixed at the maximum of that scale, the difference shall be treated as personal pay to be absorbed in future increase in pay on promotion or in future revisions.
