ORDER

1. In the G.O. 2nd Government have revised the pay scales of state Government employees on the recommendations of pay Revision Commission 1999 with effect from 1-7-1998 notionally and with monetary benefits from 1-4-1999 with effect from 1-7-1998 notionally and with monetary benefits from 1-4-1999

2. The pay Revision Commission 1999 among others has recommended the enhancements of eligibility ceiling for various existing advances for which Government employees are eligible as per Rules

2. Government after careful consideration of the recommendations of pay Revision commission, 1999 and in modification of the existing orders governing sanction of such advances to Government employees, here by enhanced the ceiling as recommended by the pay revision commission 1999 as follows
