ORDER :

In the Government Order first read above, orders: were issued constituting a Pay Revision Commission to look into the Pay Scales of the State Government employees. In the Government order second read above, orders were issued revising the rates of Dearness Allowance in the Revised Pay Scales, 1993, from the 1st January, 1999.

2. The Pay Revision Commission submitted report on 21.07.1999. Among other things, the Pay Revision Commission evolved new pay scales by merging Dearness Allowance which existed on 1.7.1998. It also recommended for 100% neutralization to all the employees and also to sanction Dearness Allowance at 0.818% of pay for every 1% of Dearness Allowance sanctioned to the employees of the Government of India.

3. Government have accepted the above recommendations and accordingly, in partial modifications of the orders issued in the Government order second read above, hereby sanction Dearness Allowance at 8.18% of pay, from the 1st January, 1999 in the Andhra Pradesh Revised Pay Scales, 1999, which came into existence from 1.7.1998 with monetary benefit from 1st April, 1999 vide Government order third read above.

4. The Dearness Allowance sanctioned in Para 3rd above shall be payable to all the Government employees, employees of Local Bodies and Aided Institutions including Aided Polytechnics, Work Charged employees who are drawing pay in the Revised Pay Scales, 1999.

5. These orders are not applicable to those employees who are continuing to draw pay in the Revised Pay Scales, 1993 and also to the Teachers of the Affiliated Degree Colleges and Universities drawing pay in the Revised University Grants Commission/All India Council of Technical Education/Indian Council of Agricultural Research Scales of 1986/1996.

6. The Dearness Allowance shall be claimed along with the pay fixation in the Revised Pay Scales, 1999 and the Dearness Allowance already sanctioned in the Government order 2nd read above shall be adjusted.
