ORDER:

In the G.O. 2nd read above Government have revised the pay scales of state Government employees, on the recommendations of pay Revision Commission, 1999 with effect from 1-7-1998 notionally with monetary benefit from 1-4-1999

2. The pay Revision Commission, 1999 among others have recommended enhancement of eligibility ceiling in respect of House Building Advance to State Government Employees, in Revised Scales 1999.

3. Government after Careful consideration of the recommendations of the pay Revision Commission, 1999 and in modification of the orders issued in G.O. 3rd read above here by enhance the existing ceiling of House Building Advance to State Government employees as recommended by the pay Revision Commission 1999 as follows:

Pay Ranges in Revised scales 1999	Enhanced Maximum ceiling Rs in Lakhs	Eligibility
A. Employees drawing basic pay upto Rs 5300/- p.m	2.50 or 60 times basic pay whichever is less	
B. Employees drawing basic pay about Rs 5300/- pm and up to 8400/-pm	3.00 or 60 times basic pay whichever is less	
C. Employees drawing basic pay above Rs	3.75 or 60 times basic pay whichever is less	

APUS

8400/- pm and upto Rs 12100/- pm		
D. Employees drawing basic pay above “ Rs 12100/- pm	4.50 or 60 times basic pay whichever is less	

Further Government ordered that House Building Advance for repairs/enlargements shall continue to be at 15 times of basic pay (Revised pay scales, 1999) subject to a maximum ceiling of Rs 90000/-.

All other conditions governing the Sanction of House Building Advances under the existing Rules will continue.

These orders shall come into force from the date

Necessary amendments will be issued to the House Building Advance Rules in due course
