ORDER:

In the Government orders 3rd read above, orders were issued for sanctioning the Additional House Rent Allowance in lieu of Rent Free Quarters, wherever payable, at 8% of the basic pay of the employees on the Revised Pay Scales of 2005, subject to maximum of Rs.500/- per month, for those employees who are working in Scheduled areas on par with the employees working outside the Scheduled areas, as laid down in G.O.2nd read above, subject to the recommendations of the One Man Committee.

2. The Government with a view to review sanction of Additional House Rent Allowance in lieu of Rent Free Quarters in the Scheduled Areas, referred the matter in the G.O. 5th read above, to the One Man Committee, constituted in the G.O. 4th read above.

3 The One Man Committee submitted its report to the Government on sanction of Additional House Rent Allowance in lieu of Rent Free Quarters and inter-alia recommended that the same rates of Additional House Rent Allowance in lieu of Rent Free Quarters as laid down in G.O. 3rd read above shall be adopted in the case of the Scheduled Areas also with all other conditions remaining the same.

4 The Government after careful examination of the report, decided to implement the recommendations of the One Man Committee on sanction of Additional House Rent Allowance in lieu of Rent Free Quarters and hereby order that the orders issued in the G.O 3rd read above shall be continued to be applicable to all those employees working in. Scheduled Areas as specified in G.O. 1st read above.
