ORDER:

In the Government Order first read above, based on the recommendations of Pay Revision Commission, 1999 orders were issued sanctioning Fixed Traveling Allowance to Government Servants who were in receipt of the same as indicated therein.

Based on the recommendations of Pay Revision Commission, 2005, orders were issued implementing the Revised Pay Scales of 2005, to the State Government Employees in Government Order second read above. The Pay Revision Commission, 2005, among others, has reviewed the existing pattern and recommended for enhancement of Fixed Traveling Allowance rates.

3. Government, accordingly, hereby order that the Fixed Traveling Allowance shall be payable as indicated below to the Government Servants who were in receipt of Fixed Traveling Allowance immediately prior to this order.
