**ORDER:**

In the Government order 1<sup>st</sup> read above, Andhra Pradesh Public Employment (House Rent Allowance) Rules, 1988 were issued.

2. Government in the Government order 11<sup>th</sup> read above, basing on the recommendations of Pay Revision Commission, 2005, issued orders revising the pay scales of the State Government employees with effect from 01.07.2003 with the monetary benefit from 01.04.2005.

3. Government in the order 12<sup>th</sup> read above, basing on the recommendations of Pay Revision Commission, 2005, issued orders on the House Rent Allowance admissible in the Revised Pay Scales, 2005.
4. The President, Telangana Non-Gazetted Officers Union, Kamareddy, Taluq Unit and the General Secretary, Telangana Non-Gazetted Officers Union, Hyderabad have represented that Kamareddy town of Nizamabad District crossed 50,000 population as per 2001 census and therefore requested for sanction of House Rent Allowance at 12.5%.
5. Further it has come to the notice of the Government that Tandur Town of Ranga Reddy District has also crossed 50,000 population as per 2001 census.
6. Government after careful consideration hereby order that the Government employees working in the Kamareddy town of Nizamabad district and Tandur town of Ranga Reddy district shall be allowed to draw House Rent Allowance at 12.5%.
7. These orders shall come into force with effect from 1-7-2003 with the monetary benefit from 1-4-2005.

#### **NOTIFICATION**

In exercise of the powers conferred by the proviso to Articles 309 of the Constitution of India, the Governor of Andhra Pradesh hereby makes the following amendment to the Andhra Pradesh Public Employment (House Rent Allowance) Rules, 1988 issued in G.O.Ms.No. 107, Finance & Planning (FW-PRC-I) Department, dated the 15<sup>th</sup> April, 1988 as subsequently amended from time to time.

The amendment hereby made shall be deemed to have come into force on the 1<sup>st</sup> July, 2003, but the monetary benefit shall accrue with effect on and from the 1<sup>st</sup> April, 2005.
