ORDER: A P U S

The Andhra Pradesh Public Employment (Organization of Local Cadres and Regulation of Direct Recruitment) order 1975, republished, with the G.O. first read above, provides inter-alia for the organization of Local Cadres in respect of posts falling under specified Gazette categories and all Non-Gazetted Categories in the Department of School Education. In accordance with the rules, orders were issued in G.O.Ms.No. 529, Education, dated 14.5.1976, organizing certain posts of Non-Gazetted and specified Gazetted Categories existing in School Education Department into Local Cadres services of the teachers and other' posts in Zilla Parishad and Mandal Parishad Schools were provincialised in the G.O. sixth read above. The Andhra Pradesh Educational Subordinate Service Rules were amended in the G.O. Seventh read above and were made applicable to the teachers and others working in Zilla Parishad and Mandal Parishad Schools. The Andhra Pradesh School Educational Subordinate Service Rules were issued in G.O. Ninth said above in super session of the previous Service Rules consequent to the, provincialisation of services of teachers and others working in Zilla Parishad and Mandal

Parishad Schools with effect from 20.3.1981 and also making the Andhra Pradesh Educational Subordinate Service Rules applicable to them/with effect from 20.3.1981, the scheme for organisation of Local Cadres in respect of the posts of all Non-Gazetted Categories in Zilla Parishad and Mandal Parishad Schools in the Department of School Education have been formulated as required under Para 3 of the Andhra Pradesh Public Employment (Organization of Local Cadres-and Regulation of Direct Recruitment) order, 1975.

2. The scheme for organization of Local Cadres has been considered and approved by the Government as given in the Annexure to this order. The unit of appointment is continued as the District as per rule 3(7) of the Presidential Order read with Para 7 of G.O. (P) No. 728, General Administration (SPF.A) Department, dated 1.11.1975. These orders were deemed to have come into force with effect from 20.3.1981.

3. The unit of appointment of the posts under the Department of School Education if the categories covered by the Andhra Pradesh Public Employment (Organization of Local "Cadres and Regulation of Direct recruitment) order, 1975, that may be sanctioned in future and anointing authorities there for shall be the same as far as the relevant categories in the scheme annexed to this order.

4. The extent of preference in favor of local Candidates in the matter of Direct Recruitment to the posts organized into local Cadres shall be as laid down in the Andhra Pradesh Public Employment (Organization of local Cadres and Regulation of Direct Recruitment) Order, 1975.

5. The Commissioner and Director of School Education is directed to scrupulously follow the above orders and the provisions of the Andhra Pradesh Public Employment (Organization of Local Cadres and Regulation of Direct Recruitment) Order, 1975 in respect of the posts which fall within the purview of the said Presidential Orders in the matter of Direct Recruitment in future and in the matter of Local Cadres.
