NOTIFICATION

In exercise of the powers conferred by section 5 and 12 of the Andhra Pradesh School Education Teachers and other Employees (Abolition of existing service cadres and Regulation of recruitment and conditions of service) Ordinance, 2005 (Andhra Pradesh Finance 12/2005) read with section 15 of the Andhra Pradesh General Clauses Act, 91 (Andhra Pradesh Act No. 1 of 1891), the Government of Andhra Pradesh hereby makes the following Amendments to the Andhra Pradesh School Educational Subordinate Service Rules issued in G.O.Ms.No.96 Education (Ser.II) dt.25-7-2005.

AMENDMENT

In the said rules:-

- (1) In rule 3, in sub-rule(ii), in the table there under, in column (3) against Sl.No.(4), for the words, "in State Council of Educational research and Training", the words "in English language Training Center" shall be substituted;
- (2) In rule 5, in sub-rule" (V), in Class I, for Category 22, the following new category shall be substituted, name!y;-"22 **Head Master of Primary School** ,

1. Must possess the qualification of at least Intermediate/HSC/SSLC/MPHSC conducted by the concerned Boards of examination of Andhra Pradesh, or its equivalent, and
2. Secondary Grade Training or D.Ed, issued by the Director of Government Examinations, Andhra Pradesh, or its equivalent".
