ORDER:

The services of the employees, specified in the Government orders cited, in the Gram Panchayats, P.Ss., and Z.Ps., have been provincialised. The Andhra Pradesh Gram Panchayat Act 1964 and the A.P.P.Sc and Z.P Act 1959 have also been amended and Provincialisation has been given effects to from 6-2-1981. Consequent on provincialisation it has been decided that the A.P. State and Subordinate Service Rules should be adopted for the employees in P.R.Bodies.

The following notification shall be published in the next issue of Andhra Pradesh Gazette.

NOTIFICATION – I

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India read with Sub-section (3) of section 36 of A.P. Gram Panchayat Act, 64 and in super session of the general rules contained in G.O. Ms No. 154,P.R.dated 15-3-1974, in the A.P. Gram Panchayat Executive Officer, regulations issued in G.O.Ms No.1136 Local Administration dated 11-3-58 and in the Andhra Pradesh Gram Panchayat Sanitary Inspectors rules 1966 issued in G.O.Ms. No. 61 P.R dated 23-1-67, the Government of Andhra Pradesh here by orders that the Andhra Pradesh State and Subordinate Service Rules as amended from time to time and subsidiary rules as issued and amended from time to time by the State Government, apply Mutatis-mutandis, shall govern the general

conditions of service of the Employees of the Gram Panchayats specified in the sub-section (1) of section 36 of the Andhra Pradesh Gram Panchayat Act,1964 with effect from 6th February,1981.

NOTIFICATION – II

In exercise of the powers conferred by the proviso to article 309 of the constitution of the India read with the sub section (4) of section 26 and Sub-section (4) of section 5 of Andhra Pradesh Public Commission and Z.Ps Act 1959 and in super cession of the rules issued in G.O. Ms. No. 986 Planning and local administration, dated 17th july,1962, the Government of the Andhra Pradesh hereby ordered that Andhra Pradesh State and Subordinate Service Rules as issued and amended from time to time and subsidiary rules as issued and amended from time to time by the state Government, apply Mutatis-mutandis, shall govern the general conditions of service of the Employees specified in the sub-section (1) of section 26 and Sub-section (3) and (4) of section 51 of the A.P.S.C. and Z.P.S. 1959 with effect from 6th February,1981.
