I wish to inform you that the selections for the posts earmarked for physically handicapped (Visually Handicapped Quota) in all the categories of posts in DSC 2003 were not finalized since some of the visually handicapped candidates have filed O.As

in the A.P. Administrative Tribunal, Hyderabad for giving preference to the percentage of blindness for their selections.

Now, the candidates have withdrawn the O.As filed by them and requested to select them based on the marks obtained by them in D.S.C. 2002 examination.

In view of the above, I request you to make selections for the posts earmarked for physically Handicapped (visually Handicapped quota) in all the categories of posts in DSC 2002 based on marks obtained by them on the following lines immediately.

- 1) The District Medical Board may be constituted for physical verification of the Visually handicapped candidates along with their original certificate.

The Board may be requested to give certificate of the genuineness of the blind candidates for the purpose of the appointment.

- 2) All the candidates who may get selections may be called for and they may be referred to the District Medical Board for verification.
- 3) After verification of these certificates, the selections of the candidates may be finalized to the extent of vacancies notified for visually handicapped.
- 4) The selection? lists may be displayed in the notice board and may be given to the press.
- 5) The posting orders may be issued with in 15 days duly conducting counseling.
- 6) The earlier orders issued in this regard vide reference 6th cited may be treated as cancelled. ,
