**ORDER :-**

The teachers M.L.C.s Federation of A.P. Teachers organizations and other teachers organizations have represented to Government to extended the facility of surrender leave sanctioned to Govt. servants in the G.Os. Ist and 2<sup>nd</sup> read above, subsequently amended in other G.Os. to the Non-Government Schools and Colleges under all managements viz., Z.Ps, P. Samithis Municipalities and aided private management.

2. The Government have carefully examined the representations and issued the following orders. In view of the fact that the leave rules of vacation Department already apply to teachers of the aided Institutions and local bodies teachers and the

question under consideration is really the facility of encashing leave and not the one of earning the leave itself.

- (i) The facility of encashment of surrender leave sanctioned to Government servant be extended to the teachers in all the non – Govt. Schools and Colleges under all managements viz., Z.Ps. P. Samithis, Municipalities and aided private managements with effect from 1-3-79.
  - (ii) The encashment of leave accumulated up to that date i.e. up to 1-3-79 be permitted only up to a maximum of 15, broken up into two parts of 8 days and 7 days.
  - (iii) The first 8 days be permitted to be encashed in a block period of 2 years 79 – 80 and the second 7 days be permitted to be encashed in the block period of 81 – 82 (calendar years).
  - (iv) After the expiry of 3 block periods i.e., after 82 (from January 1983) they be allowed to surrender earned leave as in the case of Govt. teachers according to their eligibility.
  - (v) The teachers who retire / die while in service after 1-3-79 and within the first 2 years block of 79 –80 or the family of the teachers, as the case may be permitted to encash the full 15 days (subject to eligibility) at the time of their retirement or death.
3. The Director of School Education and the Director of Higher Education are requested to take necessary steps to make budget provision in the corresponding years under the respective budget – head of expenditure.

This order issues with the concurrence of finance and planning (EE) Department vide their V.O. No. 815/DFS (M) 79.
